

## **IWSA Raffle – Terms & Conditions – 2021**

The Inner West Street Association, Inc. (IWSA) is the sponsor of this raffle and is offering the opportunity to become eligible for a drawing to win multiple cash prizes, including a \$10,000 cash grand prize. All raffle proceeds support IWSA, a registered 501(c)6 non-profit organization, developed with a mission to promote and support a diverse and vibrant economy within and surrounding the City of Annapolis' West Street MX Zoning which endeavors to preserve a sense of place and provide authentic local experiences that can foster economic, community and neighborhood revitalization.

### **TICKET PRICE**

Tickets can be purchased for \$10 each when purchased before 11:00pm, December 31, 2021

### **PRIZES**

This IWSA Raffle features 18 prizes.

1. Grand Prize: \$10,000 drawing December 31
2. 2<sup>nd</sup> Prizes: \$1000 drawing December 31
3. 3<sup>rd</sup> Prizes: \$500 drawing December 31

All final drawing will be announced December 31, 2021 at 11:45pm on Inner West Street Association's website: IWSA.com.

4. Early Bird Prizes = total \$1,500
  - a. Three (3) \$100.00 drawings on July 3 at 8:30pm (announced on stage at during IWSA's Dinner Under the Stars' Motown concert)
  - b. Three (3) \$100.00 drawings on August 18 at 8:30pm (announced on street at DUS)
  - c. Three (3) \$100.00 drawings on September 15 at 8:30pm (announced on street at DUS)
  - d. Three (3) \$100.00 drawings on October 20 at 8:30pm (announced on IWSA.com)
  - e. Three (3) \$100.00 drawings on November 17 at 8:30pm (announced on IWSA.com)
  - f. The IWSA will make all reasonable efforts to deliver the raffle prizes as described in these Terms and Conditions to the winners within 20 days of each prize drawing.

If fewer than 3,000 tickets are sold by December 31, 2021, the raffle reverts for a 50/50 raffle, with 50% of the raffle proceeds awarded to a single winner, in lieu of the other listed final drawing prizes described above. This 50/50 raffle means that 50% of the raffle proceeds, minus the cost of the early bird prizes, are awarded to one grand prize winner. *Regardless of the total number of tickets sold, the Early Bird Prizes are guaranteed.*

### **HOW TO ENTER**

Ticket price is \$10. Each eligible entry will be sequentially assigned a unique multi-digit ticket number.

Enter the 2021 IWSA Raffle in any of the following ways:

1. Online. Tickets can be purchased online 24-hours a day at [www.IWSA.com](http://www.IWSA.com). Purchaser must provide a valid email address, full legal name, phone, and physical mailing address. Payment confirmation is provided electronically at the time of your purchase. If you do not receive your

2. In-Person. Follow IWSA website, facebook & instagram for list of events where tickets may be purchased in person.
3. Due to the delays with USPS, we do not offer ticket sales via the mail this year.

## **ELIGIBILITY**

1. Raffle is only open to U.S. Residents at least 18 years of age.
2. Void where prohibited or restricted by law. All federal, state and local laws and regulations apply. Any person who resided in any area where this drawing, a game of chance, would otherwise be prohibited by law is not eligible to participate.
3. No IWSA board member, employee, contractor and their direct family members (defined as spouses, parents and children) are eligible to participate.
4. No person engaged in the marketing, development or production of raffle materials is eligible to participate.
5. The prizes may be forfeited if selected entrant(s): (1) cannot be reached; (2) fail to provide all signatures on the Release and other documents and/or to return required documents in a timely manner as required pursuant to these Terms & Conditions; or (3) cannot accept or receive prize for any reason.
6. Any or all of your entries will be disqualified at the sole discretion of the IWSA Board if you attempt: (a) to enter the raffle through any means other than as described in these Terms & Conditions; or (b) to disrupt the raffle, circumvent these Terms & Conditions, or in any way tamper with the raffle. If either of the above occurs, the IWSA Board has the right to remedy any such action disruption or circumvention, and to seek damages from you to the fullest extent permitted by law.

## **Early Bird Drawings**

1. Winners need not be present to win.
2. Early Bird winners will be drawn by an IWSA representative using an electronic random number generator and validated as random before final assignment as the prize winner.
3. All raffle tickets purchased by the time of each Early Bird Drawing are eligible to be entered in applicable Early Bird Drawings. Once a ticket has been drawn to win an early bird prize, it will remain in the ticket pool and be eligible to win subsequent early bird prizes as well as final prizes.
4. Early Bird Prize drawings will be held at 8:30pm on the following dates in 2021: July 3, August 18, September 15, October 20, and November 17.
5. Early Bird prizes are awarded regardless of the number of tickets sold.

## **Final Prize Drawings**

1. Winners need not be present to win.
2. Final prize winners will be drawn by an IWSA representative using an electronic random number generator. Every eligible ticket number will be included in the raffle prior to drawing and validated as so before final assignment of prize winner.

3. All raffle tickets purchased by 11pm on December 31, 2021 will be eligible for the final drawings.
4. Final prize drawings will take place on December 31, 2021 and announced on IWSA.com.
5. If fewer than 3000 tickets are sold by December 31, 2021, the raffle reverts to a 50/50 raffle, with 50% of the raffle proceeds, minus the cost of the early bird prizes, awarded to one grand prize winner.
6. Upon the sale of tickets in excess of 3,001 sold by 11pm on December 31, the raffle winners chosen will receive, subject to these Terms & Conditions, the awarded final prizes.

### **Winner Notification & Awarding of Prizes**

1. All winners will be notified, based on the information provided at ticket purchase by email or telephone within 72 business hours of prize drawings. If email or phone contact are not successful within 10 business days, contact will be attempted by U.S. certified mail, return receipt requested.
2. Winners will be announced online by ticket number, first name, last initial, and city of residence. Winner will be verified by matching ticket number with information provided in the records.
3. Failure of the raffle winner to respond within 20 business days of the raffle drawing will constitute a forfeiture of the prize, and a new winner will be selected and notified.
4. The IWSA is not responsible for any delays or obstacles in notification due to (a) erroneous contact information; (b) any outage or delay in internet service or access; or (c) any other circumstance which may delay or prevent a winner from receiving the prize notifications.
5. Except as stated herein, there shall be no substitution allowed for the listed prizes by a winner. A prize winner, however, may transfer the right to claim the prize.
6. All federal, state, and local taxes associated with receipt or use of prizes, including without limitation all applicable sales, use, luxury, income and special taxes are the sole responsibility of the winner.
7. The IWSA will estimate, deduct, and submit federal and state withholding taxes to the IRS from the proceeds awarded to the grand prize winner, based on amount. To claim the prizes the grand prize winner will be required to provide proof of identity, sign an affidavit of eligibility/liability/terms and liability and conditions/publicity release ("Release"), and complete IRS Form W-2G, and any other forms required by law.
